Treasurer's Report

Charlie reports 2024-25 was our best season financially, ever, with 3 main stage show in our own space. \$42,991profit from 4 shows.

Question about bar sales. Fee is not included in total. Was included in misc. Therefore, we actually lost about \$1000. Need to look at lower cost alcohol or charge more. Looking into a partnership with EVO. Will include fees in Bars Sales this coming season. Also, need more bar tenders. We must have one trained tender on sight.

President's Report

I'd like to begin by giving kudos to Rusty and the Cast/Crew of the Juke Box Revue last month. Bravo!

My thanks to Kyle Hayes for running last month's meeting. I'm told he did a stellar job! In my August report, I mentioned that we have a number of one-person committees. This not only, in my view, puts stress on individuals but also could become a challenge if the one person would become unavailable or no longer wishes to serve. Part of the solution, I believe, is to recruit more members to serve on committees. I included that in my President's column for the most recent newsletters. The other potential solution is to combine similar committees under a single umbrella. Here are some thoughts I've had: The House committee could be an umbrella that includes, Box Office, Season Tickets, Programs/Program Ads, Ushering and Bartending during performances.

- Marketing could be an umbrella for Publicity and Social Media
- Fundraising could be an umbrella that includes Patrons, Grant-Writing and Special Productions
- The general idea is that those who had previously been a one-person committee could get cross-trained on all items under the umbrella. In my view this not only eases the burden of individuals but leads to greater overall efficiency. The suggestions above, for example, take us from 15 committees to 8 (if I did my math right and don't hold me to that but it should be close)
- 2 Consider also that there may be other, better combinations. This was just my first go at it.

If there are Board members who think this might be worth pursuing, I invite you to make a motion to that effect. As I said last month, no hard feelings if no motions emerge. The grapevine has told me that nearly 80 people turned out to audition for "Annie." Congrats to Director, Sherri Trader-Hynes for handling such a large crowd. I'm sure this falls into what many would call "a good problem to have." No doubt that an excellent cast will come from it.

Performance Space - Kel Nagel

Damien and Mary are now helping.

- 1) The Board decided not to sign a construction agreement until funds were on hand or pledged.
- 2) Gillis, Gilkerson and Becker, Morgan were notified and are willing and anxious to

help. It is understood that construction costs may rise.

- 3) Kel discussed with Darrell, Kyle and Matt. All agree that we should continue fundraising efforts. Kyle says that he will participate as much as he can but will have some other commitments with CPOS and personal responsibilities.
- 4) We still need a campaign co-chair for several reasons. First is to have someone ready to take over in case Kel is unable to complete the campaign. Also, it would be helpful to have someone who can interact with possible donors who are not in Kel's usual circle of health care professionals and various political people.
- 5) Help is needed in areas other than asking people for money. We will need informational materials, including brochures, pledge cards, display materials for our show lobbies, etc. We have several creative people in graphic and fine arts who could help with these. Similar material will be needed for online promotion, both on our new website and on social media, emails, etc.
- 6) We are advised by Veronique and other professional fundraisers that we should raise seventy to eighty percent of our goal from high level donors and grants before starting a public campaign. Note that the Wicomico County Library kicked off their campaign for the new library by announcing several huge donations and then started a pledge drive with the public. We will not be seeking nearly as much money, but the approach should be similar.
- 7) Before we approach new donors, we should consider what we want to do regarding donor recognition. We could do anything from plaques on the wall, like our wall of chair donors. Or give naming rights to parts of the building such as the stage, etc.
- 8) We should consider regarding our efforts of the last two to three years to be Phase II of the performance space project, with Phase I being the time of initial acquisition of the building, and the re-modeling of the rehearsal hall, etc. We should identify previous donors and grant givers, including them in whatever donor recognition program we decide on. We should ask previous major donors what their preference is.
- 9) It is important that we have 100% donor participation by the board, just as we did for the Day of Giving last fall. Remember, the amount board members donate is not as important as the fact that all give something.
- 10) Kel will update the current total of expenses and donations for the building since we got the permits and did the parking lot as soon as this month's financials are in.
