## **Fundraising - Matt Bogdan**

1. Our second annual Spring Craft and Vendor Fair was held Saturday, March 28, from 10 a.m. to 3 p.m. at Community Players' Theater. Thanks to all who were involved in this fundraiser,

especially Wendy Stever for coordinating the event and David Allen for his work with getting the vendors in their places. We raised \$1400.

2. We are looking for teams to compete in the Community Players' Friendly Feud Fundraiser to be held April 23-26 at Community Players' Theater. We need 16 teams to compete for the grand prize of \$500, with a second-place prize of \$250. Each team will consist of five members (friends, family, coworkers), answering survey questions with the aim to score more points than the other team. The first set of eight teams will battle it out on Thursday, April 23, from 7 to 10 p.m., and the second set of eight teams will battle it out on Friday, April 24, from 7 to 10 p.m. Winners advance to play on Saturday, April 25, from 7 to 10 p.m. Saturday winners advance to the semifinals and finals, to be held on Sunday, April 26, from 2 to 4 p.m. Cost of registration is \$100 per team. If you do not want to enter a team but would like to watch the teams battle it out, admission is \$10 at the door. 3. *America 250: A Birthday Celebration* will take place on June 26 and June 27 at 7:30 p.m. and June 28 at 2 p.m. at the Community Players' Theater. Sponsored by the Wicomico Historical Society in cooperation with Community Players, a two-act presentation of patriotic speeches, songs, poems, stories and slides will celebrate America's 250th birthday. The band WW2's, who played in last year shows commemorating the men and women of the Eastern Shore who participated in WW2, will be playing, as well. Admission is free; donations accepted. ### **Grants - Matt Bogdan**

The Community Foundation of the Eastern Shore granted the Community Players an award of \$2400 to be used to help pay the stipends of counselors at the Summer Youth Drama Workshop to be held in July 2026. The Coastal Association of Realtors also contributed \$1000 toward the cause. We thank these organizations for their support.

2. As noted in our last newsletter, the Community Players has been awarded a \$150,000 Challenge Grant from the Richard A. Henson Foundation so that Players can complete renovations on the Community Players' Theater at 5109 Nutters Cross Road in Salisbury. Renovations include installing handicapped bathrooms, dressing rooms, and costume storage. In order for Players to receive the \$150,000, we need to raise \$150,000.
